Hosts International have an emergency phone number which they will send you on your booking confirmation.

- All students under 18 years old must return to accommodation before **22.30** every night. If they are late and can't be contacted, this will be reported to the police.
- Students will travel alone to and from classes and trips.
- All students under 18 years old **must** book airport transfers for their arrival and departure if travelling to the UK without their parent or guardian. You must book airport transfers with Hosts International. You will need to pay for the transfers.
- Students are not permitted to stay overnight anywhere other than the Homestay accommodation they have booked through Hosts International.

Students are not supervised by the Language Centre outside classes or university social activities and will have free time alone.
